

Membership Terms & Conditions

This membership holds true for LOL Kids Club playgrounds at “735 N Milliken Ave, Unit A, Ontario, CA 91764” and “7460 S. Rainbow Blvd, Unit 130, Las Vegas, NV 89139”. This membership agreement is also valid for products, services, party program, events, admission, advice, merchandise, information and services offered through LOL Kids Club website, ecommerce sites and webstores.

1. Description of LOL Kids Club membership. Each Member is entitled to receive seasonal discounts and other benefits on admissions, party packages, room rentals, merchandise, products or other services offered by participating LOL Kids Club playgrounds, web stores and ecommerce sites.

A) To get membership benefits, a person must be registered into LOL Kids Club Membership program. A member will be required to be in good standing to receive benefits.

B) Membership information will be announced on LOL Kids Club website at the <http://lolkidsclub.com/membership/> (the "Membership Website").

C) A Member's actual savings and benefits will vary depending upon Member's physical location in the United States and membership tiers or levels. LOL Kids Club membership cards are specific to the location from which the membership cards are bought and may not be used at other participating stores.

D) Discounts and other benefits available to Members may not be combined with discounts from any other discount program.

E) All benefits are subject to discontinuation, change, modification, improvement or substitution without notice and LOL Kids Club makes no representations or warranties with respect to, and accepts no responsibility or liability for, out of date or erroneous information related thereto.

2. Membership Term; Renewals. Your submission of membership application shall constitute your consent to receive any and all disclosures, notices and other communications including any notice that may be legally required to be provided to you regarding this Agreement, in electronic form.

6. Request paper copy of membership documents.
